GREETINGS AND THANK YOU FOR YOUR MOST SUPPORTIVE FAXES.

UNFORTUNATELY, I HAD TO TRAVEL UP TO LONDON BEFORE I RECEIVED THEM SO I AM NOW ON ROUTE BACK UP TO PLACE THEM INTO THE PROCEEDINGS.
